Program Information, Application & Agreement

Program Details:

The City of Pea Ridge Adopt-A-Street Program is a partnership between the city and the people who live and work in Pea Ridge to keep the city free of litter...one street at a time. Groups adopt a street ½-mile or more in length and agree to remove litter three (3) times per year. All groups are provided with safety vests and trash bags. The city will pick up filled trash bags after the clean-up event.

Participant Responsibilities:

- Conduct a minimum of three (3) clean-up events per calendar year.
- Follow all safety guidelines for the Adopt-A-Street program (page 3).
- Contact the city prior to clean-up dates.
- Pick up supplies (safety vests, trash bags, gloves) from the city and distribute to volunteers.
- Return extra supplies to the city after each event.
- Place full trash bags and nearest major intersection and notify the city of the location.
- Submit the "Clean-Up Completion Form" to the city after each event (page 4).

City Responsibilities:

- Provide supplies (trash bags, safety vests, gloves).
- Collect and dispose of full trash bags after the event.
- After the first clean-up, install one "Adopt-A-Street" sign recognizing the participant.

Agreement

By this agreement, the applicant and all of its authorized participants agree to abide by the program requirements and safety guidelines set forth by the City of Pea Ridge for the Adopt-A-Street program. The applicant will not hold the City of Pea Ridge responsible for any injuries suffered or damages that occur as a result of participation in this program. Applicants will automatically renew each year, unless they fail to complete the required number of clean-ups or they request to be removed from the program, at which time the signs will be removed.

The applicant agrees to the following:

1. Conduct a minimum of three (3) clean-up events per calendar year.
2. Follow all safety guidelines for the Adopt-A-Street program (page 3).
3. Contact the city prior to clean-up dates.
4. Pick up supplies (safety vests, trash bags, gloves) from the city and distribute to volunteers.
5. Return extra supplies to the city after each event.
6. Place full trash bags and nearest major intersection and notify the city of the location.
7. Submit the "Clean-Up Completion Form" to the city after each event (page 4).
8. Insure that no person under the age of 12 is permitted to pick up litter within the street right-of-way, and that all persons between the ages of 12 & 18 are accompanied by at least one adult per every five persons under age 18.

The city agrees to the following:

1. Provide supplies (trash bags, safety vests, gloves).
2. Collect and dispose of full trash bags after the event.
3. After the first clean-up, install one "Adopt-A-Street" sign recognizing participant.

Safety Guidelines

- Consider attire to avoid sunburn and insect bites.
- Wear light colored clothing, heavy gloves, sturdy shoes or boots, and a hat.
- Wear high visibility safety vests as provided by the city.
- Take as few cars as possible to the clean-up site.
- Park vehicles clear of the roadway.
- Have a first aid kit on-site.
- Have a cell phone on hand.
- Use a buddy system and look out for each other.
- Be aware of traffic situations.
- Work facing on-coming traffic.
- Work during daylight, and non-peak traffic hours.
- Stop work if weather gets bad.
- Do not over-exert yourself, especially on hot days.
- Do not attempt to handle hazardous substances (car batteries, pesticide containers).
- Avoid noxious weeds (poison ivy, poison oak).
- Avoid any sharp objects. Do not pick up syringes – please contact Pea Ridge Police Department non-emergency number at (479) 451-8220.
- Avoid areas where snakes or stinging insects may be located.
- Do not pick up litter on bridges, tunnels or overpasses.
- Refrain from picking up on street pavement.
- Stay clear of construction activities.
- Never step out into the street.
- Cross streets only at crosswalks.
- Drink plenty of water to avoid dehydration.
- Don't overload bags or attempt to lift too much weight.
- Use common sense and be alert.
