

Pea Ridge City Council
Regular Meeting
January 18, 2022

The Pea Ridge City Council met in a Regular Meeting on Tuesday, January 18, 2022 at 7:00 p.m., in the Council Room at the City Hall Administration Building.

Those present were: Mayor Jackie Crabtree, City Clerk Sandy Button, Council Members Ginger Larsen, Merrill White, Steve Guthrie, and Cody Keene. Also, present was City Attorney Shane Perry.

Others present were: Nathan See, Lynn Hahn, Annette Beard, Shane Henson, Jared Powell, Nick Larsen, Tony Townsend, Ryan Faust, John Butler, Jim Snyder, Ken Hayes and Alex Wright.

Mayor Jackie Crabtree called the meeting to order.

Mayor Jackie Crabtree opened the meeting in prayer and led those present in the Pledge of Allegiance.

Mayor Crabtree expressed the City's deepest condolences for the family of respected City developer Kevin Felgenhauer who passed away January 11, 2022.

Alderman Keene moved, seconded by Alderman Guthrie to approve the minutes of the December 27, 2021, Regular Meeting. The roll being called, the vote was as follows: Ginger Larsen voted aye; Merrill White voted aye; Steve Guthrie voted aye; and Cody Keene voted aye. Motion passed.

Alderman Guthrie, seconded by Alderwoman Larsen, moved to introduce Ordinance Number 747 by title only. The roll being called, the vote was as follows: Ginger Larsen voted aye; Merrill White voted aye; Steve Guthrie voted aye; and Cody Keene voted aye. Motion passed.

Mayor Crabtree read Ordinance Number 747 by title only, which is entitled:

AN ORDINANCE AMENDING PEA RIDGE MUNICIPAL
CODE SECTION 15.04; AND FOR OTHER PURPOSES

Alderman Keene, seconded by Alderman White, moved that the rule requiring the reading of an ordinance by title only on three different days be suspended. Mayor Crabtree put the question on the adoption of the motion and the roll being called, the vote was as follows: Ginger Larsen voted aye; Merrill White voted aye; Steve Guthrie voted aye; and Cody Keene voted aye. Motion passed.

Thereupon Mayor Crabtree declared that at least two-thirds of all members of the council have voted in favor of the motion to suspend the rule. The motion was carried, and the rule suspended. Mayor Crabtree then read the Ordinance by title only.

Mayor Crabtree read Ordinance Number 749 by title only, which is entitled:

AN ORDINANCE AMENDING PEA RIDGE MUNICIPAL CODE, TITLE 14, THE OFFICIAL ZONING ATLAS MAP OF PEA RIDGE, ARKANSAS, TO REZONE CERTAIN LAND BELONGING TO WALKINGSTICK 4525 LLC FROM AGRICULTURAL (A-1) TO RESIDENTIAL (R-3)

Alderman Keene, seconded by Alderman Guthrie, moved that the rule requiring the reading of an ordinance by title only on three different days be suspended. OF PEA RIDGE, ARKANSAS, TO REZONE CERTAIN
LAND BELONGING TO WILLOW RUN PARTNERS, INC.
FROM RESIDENTIAL R-1 TO RESIDENTIAL R-2

Alderman Keene, seconded by Alderman Guthrie, moved that the rule requiring the reading of an ordinance by title only on three different days be suspended.
