## Pea Ridge City Council Regular Meeting January 18, 2022

The Pea Ridge City Council met in a Regular Meeting on Tuesday, January 18, 2022 at 7:00 p.m., in the Council Room at the City Hall Administration Building.

Mayor Jackie Crabtree called the meeting to order.

Mayor Jackie Crabtree opened the meeting in prayer and led those present in the Pledge of Allegiance.

Mayor Crabtree expressed the City's deepest condolences for the family of respected City developer Kevin Felgenhauer who passed away January 11, 2022.

Alderman Keene moved, seconded by Alderman Guthrie to approve the minutes of the December 27, 2021, Regular Meeting. The roll being called, the vote was as follows: Ginger Larsen voted aye; Merrill White voted aye; Steve Guthrie voted aye; and Cody Keene voted aye. Motion passed.

Alderman Guthrie, seconded by Alderwoman Larsen, moved to introduce Ordinance Number 747 by title only. The roll being called, the vote was as follows: Ginger Larsen voted aye; Merrill White voted aye; Steve Guthrie voted aye; and Cody Keene voted aye. Motion passed.

Mayor Crabtree read Ordinance Number 747 by title only, which is entitled:

Mayor Crabtree put the question on the adoption of the motion and the roll being called, the vote was as follows: Ginger Larsen voted aye; Merrill White voted aye; Steve Guthrie voted aye; and Cody Keene voted aye. Motion passed.
