Pea Ridge City Council Regular Meeting April 18, 2023

The Pea Ridge City Council met in a Regular Meeting on Tuesday, April 18, 2023, at 6:00 p.m., in the Council Room at the City Hall Administration Building.

Mayor Nathan See called the meeting to order.

Mayor See congratulated Fireman Dino Collins on his retirement after serving 30 years on the Pea Ridge Fire Department.

Mayor See stated the Annual Spring Tree Giveaway, supported by a grant from the Walton Family Foundation at the recommendation of Steuart Walton will be Friday, May 19th at 9:00 a.m. This event will be at the Pea Ridge City Hall, 975 Weston Street. Residents can receive one tree per household with proof of residency, i.e., utility bill, driver's license, etc. There will be twenty-five each of the following; Pecan, Tulip Popular Tree, Bur Oak, Swamp White Oak, Chickasaw Plum, and seventy-five Witch Hazel.
