Pea Ridge City Council Regular Meeting October 17, 2023

The Pea Ridge City Council met in a Regular Meeting on Tuesday, October 17, 2023, at 6:00 p.m., in the Council Room at the City Hall Administration Building.

Mayor Nathan See called the meeting to order.

Mayor Nathan See opened the meeting in prayer and led those present in the Pledge of Allegiance.

Alderman Neil moved, seconded by Alderman Keene to approve the minutes of the September 19, 2023, Regular Meeting. Regarding the MLDP-CDL employee Drug Testing Program, CDL testing will continue to be included in the MLDP dues, but the Optional Non-CDL Drug Testing Program will not be offered or administered through MLDP in 2024. The total amount due for these two services is \$12,174.15. The amount last year was \$15,453.65.
