Pea Ridge City Council Regular Meeting August 20, 2024

The Pea Ridge City Council met in a Regular Meeting on Tuesday, August 20, 2024, at 6:00 p.m., in the Council Room at the City Hall Administration Building.

Mayor See called the meeting to order.

Mayor See opened the meeting in prayer followed by the Pledge of Allegiance.
