- The license fee is not returnable in case the license, for any reason, surrenders their license, discontinues their business, or if the application is denied or the license revoked for violation of any city, county, state or federal ordinance, law, statue or regulation. (Refer to code 4.24.14)
- All licenses are non-transferable and non-assignable. (Refer to code 4.24.15)
- Please post all license in a permanent place where the business covered is carried on. The holder is required to present the license to any officer or official of the city. (Refer to code 4.24.16)
