## Pea Ridge City Council Regular Meeting September 16, 2025

The Pea Ridge City Council met in a Regular Meeting on Tuesday, September 16, 2025, at 6:00 p.m., in the Council Room at the City Hall Administration Building.

City Clerk Button called the meeting to order.

Alderman Keene opened the meeting in prayer followed by the Pledge of Allegiance.
